

ROUSDON OWNERS AND RESIDENTS ASSOCIATION (ROAR)
100 CLUB RULES

1. The 100 Club complies with the rules of the Gambling Act 2005 (amended by Regulation 2007) for a Private Society Lottery.
2. The name of the draw is 'Rousdon Owners and Residents Association 100 Club' regardless of the number of members. Hereafter referred to as the '100 Club'.
3. The 100 Club will be administered by the '100 Club Administrator' appointed by the ROAR Committee. Applications to join the 100 Club shall be made to the 100 Club Administrator and can be applied for by post or electronically. If the registration is made electronically it is deemed that participants using this method agree to the 100 Club rules and agree to their details being kept securely on computer.
4. The 100 Club is open to all residents and owners who must be aged 16 years or over. Guests of resident's and owners may also participate in the Lottery provided they purchase their tickets while present on the Estate. Tickets shall be sequentially numbered and allocated from (1) onwards. Participants are entitled to hold any number of tickets.
5. Making a payment to join the 100 Club whether by cheque or by payment made directly into the ROAR bank account deems that participants agree to the 100 Club rules.
6. The 100 Club will run in periods of one year, commencing in 1 April 2014. If the 100 Club does not run then any amounts received in respect of that year's 100 Club will be refunded.
7. The subscription for each ticket is £6 per quarter payable annually (£24) in advance by cheque (payable to ROAR), cash, direct bank payment or Standing Order. A reminder will be sent out in January of each year.
8. Members are permitted to join at any time throughout the year, paying the appropriate balance to the end of March. Members joining part way through a quarter may only pay the full quarterly cost of £6 in order to be entered in the next quarterly draw.
9. The total income collected will be split 50% prize money and 50% to ROAR. There will be four quarterly draws of three prizes allocated as indicated in our covering letter. All running costs will be covered by ROAR funds.
10. In the event of any surplus funds raised, the committee may agree to have a further Christmas Draw, use on environmental projects or alternatively to make a donation to a local charity.
11. The draw will be held at the quarterly ROAR Committee meetings. All members are entitled to attend. Should the meeting not coincide with the draw for any reason then a special draw will take place but must be in the presence of at least three members.
12. The winner of each draw will be contacted using the winner's preferred method. Any cheque not cashed within 6 months will be deemed a donation to ROAR. A list of prize winning numbers for each draw will be published on the ROAR Notice Board and in the next available copy of the Rousdoner.
13. Members' details will be held securely on computer for ROAR purposes only and it is up to members to keep the Administrator informed of any changes.
14. The ROAR Committee reserves the right to alter the rules of the 100 Club, as made necessary and informing the members in writing or electronically.
